I, for myself, and on behalf of my heirs, assigns, personal representatives and their next of kin, hereby release, hold harmless and waive any liability as against Stacey's Surf Camp LLC and all of their shareholders, members, principals, officers, directors, board members, agents, employees, assignees, sponsoring agencies and entities, associates, officials, agents and other participants with respect to any and all claims, actions, causes of actions, including negligence, debts, dues, sums of money, damages, judgments, liabilities and the like, arising out of my participation in the Surf Camp to the fullest extent permitted by law.
